### **Meet the President**



Jack Quarter is a professor at OISE, University of Toronto, and the co-director of the Social Economy Centre. His recent books include Understanding the Social

Economy: A Canadian Perspective (University of Toronto Press, 2009), written together with Laurie Mook and Ann Armstrong; What Counts: Social Accounting for Nonprofits and Cooperatives, 2nd Edition (Sigel Press, 2007), with Laurie Mook and BJ Richmond, and Researching the Social Economy (University of Toronto Press. forthcoming), edited together with Laurie Mook and Sherida

Ryan. He is the applicant for several SSHRC research grants including a newly funded CURA on Social Business and Marginalized Social Groups and also the Southern Ontario Node of the Social Economy Suite. In addition to the social economy, his research focuses upon nonprofits, co-operatives and volunteering, and he teaches in the field of community development.

### **Meet the President Icont'dl**

JQ: My interests started with cooperatives in the early 1980s and then branched out from there. I was living with my family on a kibbutz in Israel in 1980-81 and became fascinated with cooperatives. I realized that I had gone through the entire Canadian school system without learning anything about co-operatives. When we returned to Canada, I became involved with worker co-operatives. founding and editing a magazine, and then helping to form a national federation in 1990, and became involved with an education project on co-operatives, together with the Cooperative College of Canada. In 1992, my book, Canada's Social Economy, was published, and subsequently I became involved in research on measuring the value of volunteering with Laurie Mook and

Betty Jane Richmond. If you don't mind, I will put in a plug for our new book (with Laurie Mook and Ann Armstrong), Understanding the Social Economy: A Canadian Perspective (University of Toronto Press, November 2009).

SR: Professionally speaking, what are you excited about now? What drives you?

**JQ**: I was once in psychoanalysis trying to figure out what drives me, but I never arrived at a good answer. I enjoy my work and take meaning in it. Part of the satisfaction is the people I work with -bright, energetic graduate students and colleagues in Canada and internationally with whom I share mutual interests.

**SR**: Why have you gotten involved with ANSER?

**JQ**: In 2007 following the Congress at the University of Saskatchewan, a group of us decided to form an association that would be a place for researchers of nonprofits and the social economy in Canada to meet and share their work. At first, some of us attempted to broaden a related organization, CASC, which specializes in research on cooperatives. However, the CASC membership resisted, so we moved ahead on our own. There were six of us: Vic Murray, Peter Elson, Laurie Mook, Michael Hall, Keith Seel and myself. We met once a month and each of us took on tasks between meetings. but we never dreamed that we

**SR**: What role do you see ANSER playing in the future?

**JQ**: I hope that ANSER can continue to grow. We have started a publication, the Canadian Journal of Nonprofit and Social Economy Research, a newsletter, student research awards with the generous support of the Institute for Nonprofit Research at Mount Royal University. There is lot of positive energy and who knows what will happen next.

**SR**: On a more personal note, what do you do in your spare time?


JQ: Walking the dog, burning rubber on the Galloping Goose Trail in Victoria, reading either novels, biographies or history, playing bridge. I used to be a hockey fan, but it is difficult when you live in Toronto. I gave up after my son, David, stopped

playing organized hockey. The joke I enjoy is: What do the Toronto Maple Leafs and the Titanic have in common: they don't do well when they hit the ice.

**SR**: What is your favourite book and why?

JQ: I read a lot, so that is a difficult question for me. I gave the nominating presentation for an honorary doctorate at the University of Toronto for the novelist/short story writer, MG Vassanji; his book, the In Between World of Vikram Lall, is extremely powerful. I put forth Lawrence Hill for an honorary doctorate this coming year, but haven't heard as yet whether he will get it. His signature work, the novel, Book of Negroes, should be compulsory reading in our schools. I was heartened to see that it still is on the best

seller list after 75 weeks. One of my alltime favourites is the Poisonwood Bible by Barbara Kingsolver, and I found the two novels by Kaled Hosseni. A Thousand Splendid Suns and the Kite Runner. extraordinarily powerful. I enjoy John Steinbeck novels (Grapes of Wrath, the Pearl, Of Mice and Men), Rohinton Mistry's, A Fine Balance and Aravind Adigo's, the White Tiger. The last biography I read was the Forger's Spell, the story of the art forger, Han van Meegran: others that are memorable were An **Unassuming Genius** (Alexander Graham Bell); and the Scott Expedition. I have read several of Ken McGoogan's books on the Northwest Passage. I also read a lot on the history Middle East, and hope to see the day when the tragic conflict between Israel and Palestine is resolved.

Following fifteen year as an Executive Director. Peter made the transition to academic life, first by completing an MSc in Voluntary Sector Organization at the London School of **Economics and Political** Science and later by completing his PhD in Adult Education and Community Development at the University of Toronto. He is currently Senior Research Associate at Mount Royal

University. He has served on the ANSER steering committee since its inception and is currently serving a three-year term on the board. He has served as chair of the Administration committee and was recently appointed English Language Editor of ANSER's new journal, the Canadian Journal of Nonprofit and Social

Economy/Research/J ournal canadien de recherche en économie sociale. A book based on his PhD thesis has been accepted for publication by the University of Toronto Press and will be published in July, 2010.

### **Board Member Profiles: Lucie Dumais**

Lucie Dumais is a Professor of Social Policy at the School of Social Work at the Université du Québec à Montréal. A sociologist and political scientist, she has worked in academia (in Québec and Ontario) for 20 years. Lucie Dumais is the Director of Laboratoire de Recherche sur les Pratiques et les **Politiques Sociales** (LAREPPS) with Dr. Christian Jetté and Chair of the Knowledge Transfer Committee at l'Alliance de Recherche UniversitésCommunautés en **Economie Sociale** (ARUC-ÉS). She has research experience in occupational health, work organizations and social policy and has worked in interdisciplinary settings, such as universitycommunity partnerships (with unions and community groups). Recent research includes evaluative studies in areas of disability, immigration

(in Quebec and in Canada) with special attention to employment supports and community group supports, as well as comparative studies of policies and programs. Other research addresses issues related to nonprofit organizations in the sector of social housing, as well as urban local development officers challenges.
